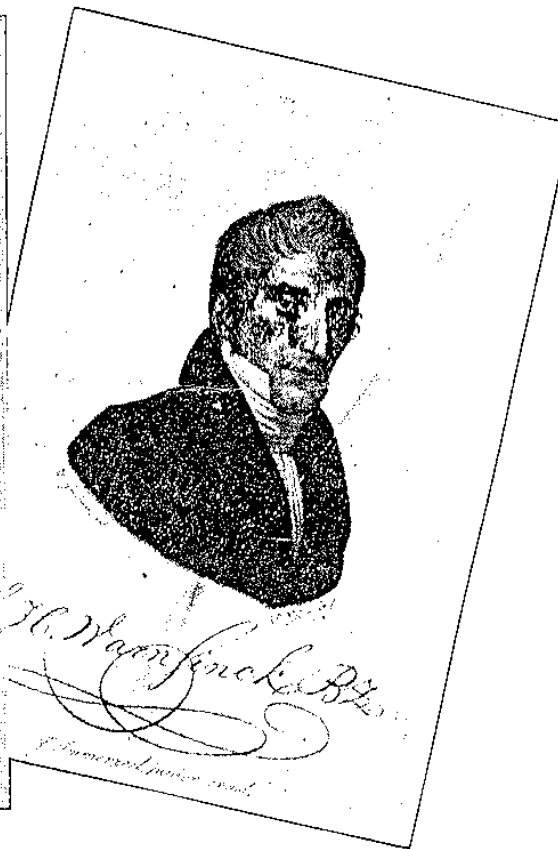
History

- Oegstgeest (January 27, 2005)

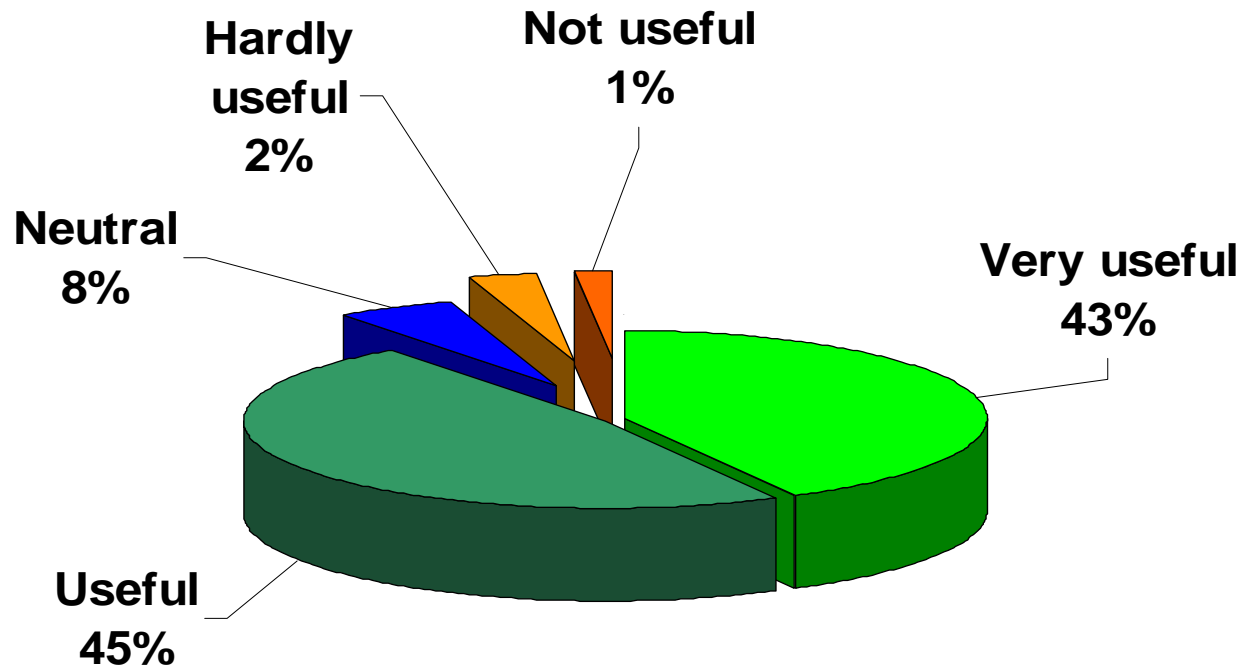
- Problem!

Internal

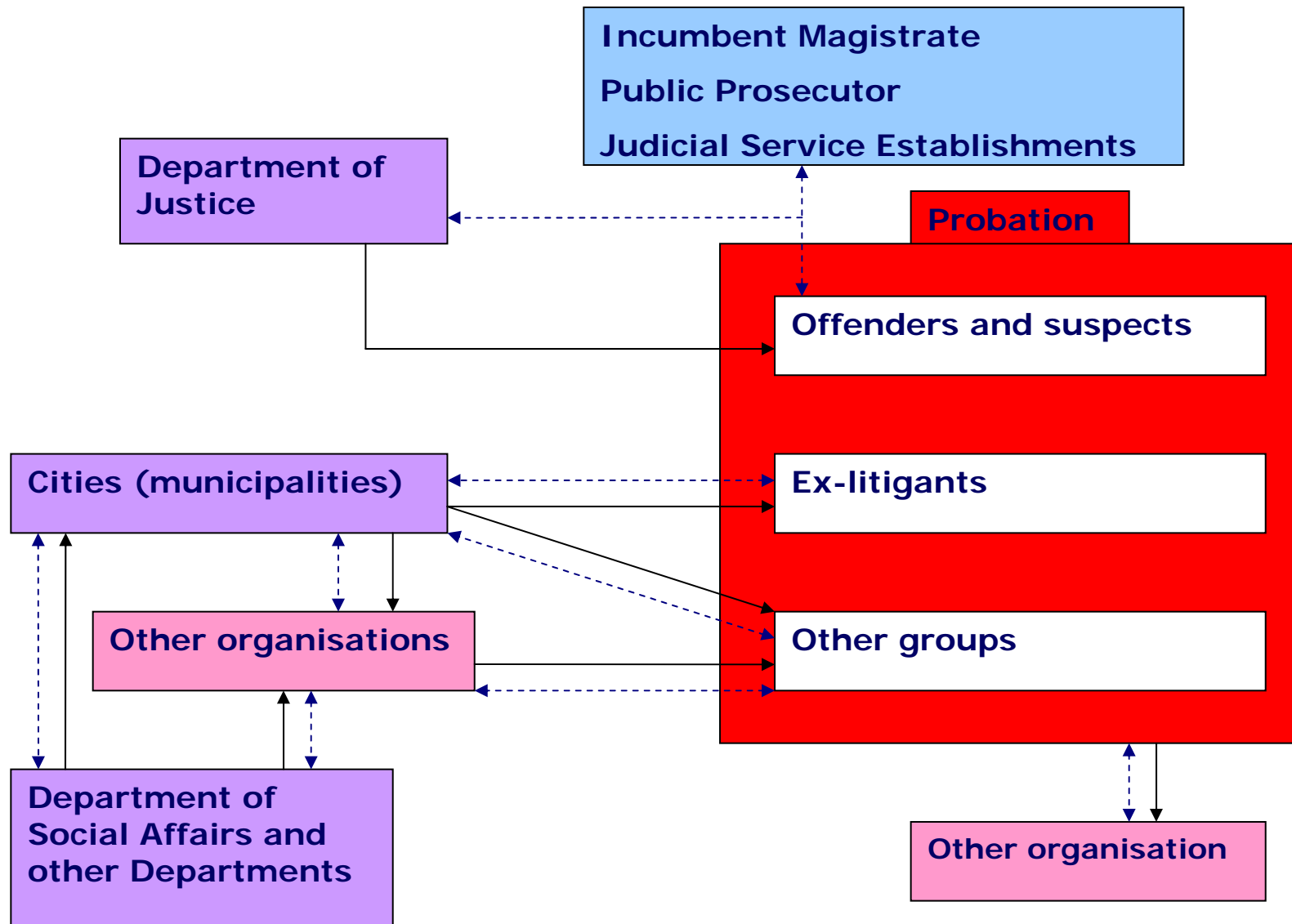
- Projectmanager business development
